## Britain's leading, longest-established national independent rail campaign



We celebrate seven decades of rail campaigning successes this year! Today's Railfuture has its origins in the days of the post-war governments of Attlee, with Alfred Barnes as Minister of Transport and James (Jim) Callaghan his Parliamentary Secretary when the 1947 Transport Act nationalised the railways in 1948, and then of Churchill from October 1951, Lord Leathers his Minister for Co-ordination of Transport, Fuel and Power.

In November 1951 the **Society for the Reinvigoration of Unremunerative Branch Lines (UK)** had its first public meeting; influenced by John Betjeman, it then changed to the simpler **Railway Invigoration Society**. The **Railway Development Association** also formed that year, and the two organisations came together in 1978 as the **Railway Development Society**. In 2021 we also celebrate the 21<sup>st</sup> birthday of **Railfuture** as first the campaigning, then successor, name for RDS.

With over 40 new/reopened stations and over a dozen new/reopened rail links to our branch's credit, here are the first-quarter anniversaries of our local successes:

### January

- ~ Gospel Oak again became the terminus for Barking services, rather than Kentish Town, in 1981 – 40<sup>th</sup>!
- ~ Ashford International Eurostar platforms opened in 1996 - 25<sup>th</sup> anniversary marked by service suspension.

### February

- ~ Garston, Herts station opened in 1966 – 55<sup>th</sup>!
- ~ Dalston Junction <> Highbury & Islington London Overground services opened in 2011 - 10<sup>th</sup>!

### March

- ~ Heathrow Airport Terminal 5 station, and its link from Terminals 1, 2 & 3, (Heathrow Central) opened in 2008.

## “100 more by ’24” – the final 15?

Railfuture’s national campaign for the [Access for All](#) programme to be expanded has now been running under that strapline for 18 months. The Chancellor of the Exchequer’s Spending Review announcement last November did not take the opportunity to fund another 15 stations, to reach our target of “100 more by ’24”!



His 2021 Budget in early-March was to be the next such opportunity, as we recall that it was the 2020 Budget last March which added 12 more stations to the growing list of step-free stations, eight in our regional branch area, as reported in [railse no.148](#) last June. Network Rail’s latest update was last December, [here](#).


One of last year’s extra eight added to the DfT’s Access for All programme is the Uckfield line’s Eridge. It’s also been the southern terminus of the Spa Valley Railway for the decade since March 2011, reported in [railse no.112](#) in June 2011. A subdued 10<sup>th</sup> birthday!



For a station of such relatively low usage – not quite 130k in the most recent ORR estimates, for 2019/20 – it’s already been doing very well out of some [substantial Network Rail investment](#). The Railway Heritage Trust is also grant-aiding the restoration of a waiting room. Installation of the 16-person lift for the Uckfield line’s bi-directional platform, via its opposite face and standing in the redundant track-bed, is due to commence in May for expected completion in October. Designated Blue Badge parking bays directly outside the station entrance may still be an unresolved issue.

**Our vision for rail:** *A railway system that provides services which travellers and freight forwarders want to use, and which offers more journey opportunities to more people and more freight.*

## And another one in ’21!




From Southern to Southeastern, [St. Mary Cray station](#) in the London Borough of Bromley is also getting the step-free treatment. ORR-estimated usage in 2019/20 of c.1.7million ensured that this originally CP5 scheme, deferred by the Hendy Review, was reinstated to CP6 in the DfT’s April 2019 announcement of 73 stations in the Access for All Programme to 2024, as reported in some detail in [railse no.144](#) for June 2019.

Last year my grandad received the recognition he deserved, and was celebrated at the House of Lords for his achievement of being 'The First Black British Train Driver'. ## Vote 2021 – Thursday 6 May

Pandemic lockdown is expected to relax sufficiently, and the uptake of postal voting is expected to increase, to enable this year's local elections to go ahead.

Below is a summary of contests which offer Railfuture members, as individual private citizens, opportunities to raise rail matters with their own local candidates.

## Rother Valley Railway

The DfT's Transport Infrastructure Planning Unit has advised us of the second revision to the timetable for the Public Inquiry primarily to hear unresolved objections to the application for the proposed Rother Valley Railway (Bodiam to Robertsbridge Junction) Transport & Works Act Order. The Pre-Inquiry Meeting is planned to be on 12 May, ahead of the main Public Inquiry due to start on 6 July. Further details in the [dedicated Inquiry website](#).

# TfSE rail – east of East Sussex: EBN-BEX-SLQ-HGS-RYE-AFK-STP

Railfuture calls for new highway improvement scheme! Did you read that here first? On Highways England's A259 north-east of Rye a [very close shave](#) highlighted the safety risk of main roads having level crossings.



A new 3km NE-SW bypass would avoid level crossings at Star (above incident highlighted) and East Guldeford, as reported on page 5 in [railse no.140](#) for June 2018. It would support raising the line-speed from 60mph to 90mph, part of a MarshLink upgrade for HS1 services.



The [Transport Strategy](#) adopted by Transport for the South East looks forward to a 108% rise in rail travel within the next 30 years (1991 is not that long ago!) The Railfuture-inspired, and Hastings and Rother Rail Users Alliance / local MPs-supported, new Eastbourne - Ashford International service is showing the way. The first year of the recast timetable from May 2018 generated a 10% jump in station usage, setting nine **new records** shown in the table below, followed by a further 2% growth in the pandemic-affected second year which still set another eight **new all-time highs!**

Whatever happened elsewhere on the GTR network in May 2018, for which the Passenger Benefit Fund is the fine returned to passengers as station improvements, East Coastway / MarshLink was a beacon of success!

As trailed in the previous [railse no.150](#), Network Rail's 'Kent & East Sussex Coastal Connectivity Programme' is imminent. Kent County Council has published its report on the consultation responses to its draft, now revised, [Kent Rail Strategy 2021](#), including support for new HS1 services for the east of East Sussex coast.




Consultation on the [draft Hastings Local Plan](#) closes on Wednesday 24<sup>th</sup> March.

Closing on Wednesday 31<sup>st</sup> March is the opportunity to make representations to the Planning Inspectorate on the application by London Resort for a Development Consent Order for a leisure and entertainment resort on Kent's Swanscombe Peninsula. Our response to the pre-application consultation last year is [here](#). The employment opportunities for, and incomes brought back to, Hastings will be attractive with Ebbsfleet and Ashford International stations only 20 minutes apart – Hastings and Ashford in future only 30 minutes apart!

# TfSE rail – N. Downs Line east and Medway Valley line extension: Surrey - Kent SOO-MDB-PDW-TON-EBR-GDN-RDH

In [our response](#) last year to Kent County Council's consultation on their draft Kent Rail Strategy 2021 we advocated a Cuxton Chord to link the Medway Valley line and the Chatham Main Line. Recognising the engineering challenges to be overcome, this would enable direct orbital rail links for the Medway Towns.




While not an action in the new [Kent Rail Strategy 2021](#) the TfSE Inner Orbital Area Study can take it forward.



“Councils and TfL draw up plans for a rail M25” – that was a headline in 2013! Surrey County Council was raising the idea in its then-new county rail strategy.




If imitation is the best form of flattery then along comes Railfuture with our Thames Valley-Medway Valley **R25**.

## TfSE rail – West Coastway: West Sussex - Hampshire BTN-HOV-SSE-WRH-LIT-BOG-CCH


Complementing ‘east of East Sussex’ (opposite left) both are shown below in the context of TfSE’s Study for the Outer Orbital Area; it also overlaps with ‘west of East Sussex’ (right) in the South Central Radial Area.



Railfuture is represented in the ‘task and finish’ Forum for each Area Study, to identify shortlists of priority interventions for next year’s Strategic Investment Plan.

## TfSE rail – west of East Sussex: BTN-FMR-LWS-UCK-COH-ERI-TBW

TfSE’s South Central Radial Area includes a newly-recognised economic corridor, between Brighton and Tunbridge Wells. Will this become our future **R22**?



Each area study’s geography is based round the most important economic corridors in the region. These ‘corridors of opportunity’ connect the biggest towns, cities and international gateways and include the greatest opportunities for sustainable economic growth.

Coincident with TfSE’s work, Wealden District Council embark on their new Local Plan; a *Direction of Travel* consultation attracted [our response](#) in January. The District, however, has limited options for planning its required housing growth based on rail, existing or proposed: the East Coastway between Pevensey Bay and Berwick, the Uckfield line up to Ashurst (Kent), the Hastings line between Stonegate and Tunbridge Wells.



For Railfuture, sustainable communities must mean rail-connected communities; new homes must mean [#RailTransportForNewHomes](#), not car-dependency.

Underlying is the principle of ‘Place-making’, simply expressed as the processes of creating quality places in which people want to live, work, play, and learn. As an economic development strategy, it is the practice of using a community’s public amenities to make economic progress. Transformative place-making aims to nurture an economic ecosystem which is regionally connected, innovative, and rooted in the assets of its local residents and businesses.

That is the fundamental challenge, as we see it, for TfSE – transport, like place-making, is a means to an end; as we say: “*Better lives through better journeys.*”
